Inside the three-story courthouse, a museum highlights the area's historical treasures.

Hocking Hills, Ohio

A weekend getaway in the Hocking Hills region of Ohio is perfect for couples. There are quaint cabins and inns tucked away in the woods throughout this southern Ohio region. The Hocking Hills is Ohio's natural retreat, attracting





people who are looking for a day hike or a quiet weekend. You will want to start in the Hocking Hills State Park near Logan, which has more than 2,300 acres of forestland.

Door County, Wisconsin The 100-step climb to the top of Cana Island Lighthouse in Bailey's Harbor rewards visitors with some of the best views of Lake Michigan's Door County shoreline. Walk along the rock-ledge shore for great photo ops of the 1870s-era lighthouse, or stack stones and leave a little statue behind. Triton College's School of Continuing Education Receives Prestigious 'Collaboration Award' from the American Nephrology Nurses Association

The Triton College School of Continuing Education, Center for Health Professionals (CECHP), received the prestigious Collaboration Award from the American Nephrology Nurses Association (ANNA). Triton was presented with the recognition at the ANNA's 2024 Annual Symposium held last month in Orlando, Florida. In partnership with ANNA, Triton developed the Nephrology Certification Exam Preparation course to assist medical professionals (dialysis technicians and registered nurses) with passing their board certifications. The course provided ANNA with an opportunity to continue its Nephrology Nursing Certification Review Program halted during the pandemic. ANNA had been offering the course consistently since 2008. With Triton's wellestablished Hemodialysis Technician course and

its Nursing Program, the ANNA approached Doligosa to see if they could utilize Triton's space. With Doligosa's assistance, ANNA constructed a course that met Illinois Continuing Education guidelines and submitted a proposal to

the Illinois Community College Board (ICCB). Formal test questions were provided for each section of the class that aligned with the graduating system of Triton. The course was approved in January 2023 and held in April 2023. The program was repeated in November 2023, with six RNs enrolling in the class. All students plan on taking the certification test within the next six months.

El Triton recibió el reconocimiento del Simposio Anual 2024 de ANNA efectuado el mes pasado en Orlando, Florida. En colaboración con ANNA, Triton desarrolló el curso de preparación de Examen de Certificación de Nefrología para asistir a los profesionales médicos (técnicos de diálisis y enfermeras registradas) para pasar las certificaciones de la junta) El curso dio a ANNA la oportunidad de continuar su Programa de Revisión de Certificación de Enfermeras en Nefrología suspendido durante la pandemia. ANNA ha estado ofreciendo el curso constantemente desde el 2008. Con el bien establecido curso de Técnico en Hemodiálisis del Triton y su Programa de Enfermería, ANNA se dirigió a Doligosa para ver si podían utilizar el espacio del Triton. Con la ayuda de Doligosa, ANNA construyó un curso que cumple con las guías de Educación Continua de Illinois y envió una propuesta a Illinois Community College Board (ICCB). Se proporcionaron preguntas de prueba formales para cada sección de la clase que se alineaban con el sistema de graduación de Triton. El curso fue aprobado en enero del 2023 y ofrecido en abril del 2023. El programa se repitió en noviembre del 2023, con seis RNs inscritas en la clase. Todos los estudiantes planean tomar la prueba de certificación en los próximos seis meses.

Bedford Park Suspect Arrested, Charged by Bridgeview Police in **Remote Car-Start Killing**

A 20-year-old Bedford Park man was arrested and charged with First Degree Murder late Friday evening in the shooting death of a Bridgeview man who was walking to his car, which he remote started. Arturo Cantu, 39, was shot twice as he left his apartment at the 7300 Block of 79th Street at 5 AM on Wednesday, May 15, 2024 on his way to work.

Bridgeview Police charged Anthony Calderon, 20, with First Degree Murder building where he was pronounced dead at the scene, Bridgeview Police Chief Ricardo Mancha said Saturday. Joined by the Major Crime Task Force, the Bridgeview Police were able to secure video from nearby business establishments to help identify and lead them to the suspect who was arrested Friday.

The First Degree Murder charges against Calderon were approved by the Cook County State's attorney




in the killing late Friday night. Cantu was walking to his car when he was confronted by the suspect. Anthony Calderon, who is from the 7700 Block of 65th Place in Bedford Park, Illinois.

Cantu's body was found on the side of his apartment late on Friday night, May 17, 2024. Mancha said that the shooting was an isolated incident and that the investigation into the reason for the assault and killing are under continued investigation.

Villanueva Champions Measure to Give First-Time Offenders a Second Chance

State Senator Celina Villanueva passed a measure through the Senate to ensure those who plead guilty to a possession charge receive a second chance in exchange for diversion into a probation program. Currently, a person who successfully completes a probation program will have their sentence or conviction vacated. This clean record applies while the person is enrolled in the program as well as for those who successfully complete the program. House Bill 5285 would protect individuals



who plead guilty to a possession charge in exchange for diversion into a probation program with the promise that a felony will not be included

on their record upon successful completion of the program. This measure is necessary because background checks often misinterpret diversion into special probation programs as a "conviction." House Bill 5285 passed Senate Thursday and heads to the governor for further consideration.
