# Let Children Play

Focusing on a holistic approach to improving physical and mental of families across the City of Chicago, the Chicago Department of Public Health (CDPH) will once again transform neighborhoods into a safe play space for children to enjoy with the help of the PlayStreets initiative. "Having safe places to play and exercise helps families build the foundation for healthy bodies, minds and social skills," said Olusimbo 'Simbo' Ige, MD, MPH, CDPH Commissioner. "Through these safe play spaces families can spend time together, reducing anxiety, depression, and improving moods while building relationships with other children and families. Combating health disparities starts with removing the

structural barriers that limit opportunities for safe recreation outdoors."

PlayStreets closes specific neighborhood streets to traffic for three or more hours to transform the community into safe, supervised play areas for families to stay active and healthy. This PlayStreets will Week highlight prioritized communities and the organizations dedicated to servicing the children and families who live in these areas. Since 2012, the Chicago Department of Public Health has issued summer implementation grants and offered technical support to various communitybased organizations, such as the Back of the Yards Neighborhood Council and Impact Family Center for the development of PlayStreets in underserved communities on the South and West sides. "We thank CDPH and the current

administration for allowing us to bring PlayStreets to the most in need communities on the Far South Side," said Tina Sanders, Chief Executive Officer, Phalanx Family Services. "PlayStreets provides fun and healthy activities for our youth and their families. These events are a great resource in connecting communities to much needed resources and information this summer."

PlayStreets events usually feature various sports activities, games, bounce houses, dancing, fitness classes, healthy snacks, and more. Last summer, more than 30,000 residents participated in 180 PlayStreets events across the city. This year, an "End of School Year, Summer Kick Off" launch of the PlayStreets program had 30 PlayStreets events occur, with more than 200 scheduled for later this summer. BUILD,

Services are coordinating the events this year on behalf of CDPH. They are working with more than 30 grassroots community partners to help host the events and empower residents to take back their streets for fun and fitness. "We are proud to partner with the City of Chicago to provide opportunities for children, youth and families to participate in PlayStreets events across the city," said Adam Alonso, Chief Executive Officer of BUILD, Inc. "Sometimes we forget how important play is for children. It is fundamental. Let's go out and play."



# **Sheriff Dart Warns Public of Phone Scam**

Cook County Sheriff Thomas J. Dart is warning the public of a telephone scam during which callers, who identify themselves as Sheriff's Office employees, tell individuals they must come to a Sheriff's Office location to a pay a fine or face arrest. Cook County Sheriff's Police have received multiple reports from individuals who said they received a call from someone claiming to be with the Cook County

Sheriff's Office. The caller threatens arrest if the individual does not go to the Daley Center or Sheriff's Police Headquarters in Maywood to pay fines for missing jury duty or for an outstanding warrant. Most people reported receiving this call from a blocked number. The public should be aware these calls are a scam. Sheriff's officers never ask for immediate compliance with orders over the phone nor call individuals to inform them about outstanding warrants. The public is advised that if they receive a call from someone claiming to be a law enforcement officer to get the caller's full name, badge number, and phone number. Do not follow the caller's instructions. Instead, call the department they claim to be from to verify the caller's identity and determine if there is a reason for contact. Anyone who believes they are a victim of this scam is








## PNCC Kicks Off The 52nd Annual Fiesta del Sol with Opening Reception and Scholarship Award Ceremony



# **Treasurer Maria Pappas Sending \$22M in Automatic Refunds**

Cook County Treasurer Maria Pappas is sending more than \$22 million in automatic refunds to more than 10,000 property owners who overpaid their property taxes last vear. Most automatic refund recipients will not have to file applications, fill out forms or deal with any paperwork. Some will have refunds directly deposited into bank accounts, while others will be mailed checks. The \$22 million in refunds will be distributed to owners of 10,099 properties. Of those, 5,813 will have funds directly deposited and 4,286 will receive checks in the mail by Aug. 9. Visit cookcountytreasurer. com to see if you have an automatic refund coming. Select the purple box labeled "Your Property Tax Overview" and enter your address or 14-digit Property Index Number (PIN). Most



of the refunds will go to homeowners receiving property tax exemptions, which are applied to the Second Installment tax bill and reduce the total taxes due. Exemptions include Homeowner, Senior Citizen, Senior Freeze and

Disabled Persons. Second Installment 2023 bills are due on Aug. 1. Since launching the automatic refund program in 2018, Pappas has refunded about \$143.2 million to more than 165,114 property owners without the need

for applications. Property taxes are due in two annual installments. First Installment bills are an estimate that is 55 percent 3of a property owner's total bill for the previous year. First Installment 2023 bills were due March 1<sup>st</sup>.

## Streamwood Man Charged with Possession of Child Pornography



A30-year-old Streamwood man has been charged with possession of child pornography following a Cook County Sheriff's Police investigation, Sheriff Thomas J. Dart announced today. On Monday, July 22, Sheriff's Police Internet Crimes

Against Children (ICAC) Unit investigators arrested Jose Hidrogo, of the 100 block of Red Cedar Drive, after numerous sexually explicit files of children under the age of 13 were found on his cellphone. The investigation was initiated after ICAC investigators received a tip from the National Center for Missing and Exploited Children regarding images and videos of child pornography saved on a cellphone provider cloud storage app linked to Hidrogo.

Investigators obtained a search warrant for the account and verified that it contained child pornography. On July 9, ICAC investigators interviewed Hidrogo at his home. After being issued his Miranda Warning, Hidrogo confirmed that the cellphone associated with the cloud storage app belonged to him. Investigators took possession of Hidrogo's cellphone, and a forensic analysis of the phone revealed approximately 100 images and 40 videos of child pornography, many involving victims under the age of 13.

On Monday, the Cook County State's Attorney's Office approved one count of Possession of Child Pornography/Videos/Vic <13, a Class 2 Felony. Hidrogo appeared today at the Rolling Meadows Courthouse for his initial court hearing on the charge, after which he was ordered detained pending trial. Since 2020, investigations by the Sheriff's ICAC Unit have led to charges against 49 individuals for cases involving the victimization of children and child pornography. The public is reminded that the defendant is presumed innocent until proven guilty by the government in a court of law.
