## El Gobernador Pritzker Firma una Ley Histórica que Amplía Aún más los Derechos Reproductivos en Illinois

El miércoles, el gobernador JB Pritzker, junto con legisladores y líderes de derechos civiles, firmó varios proyectos de ley diseñados para proteger aún más los derechos reproductivos en Illinois. Los proyectos de ley firmados incluyen HB581, que garantiza que las mujeres embarazadas puedan acceder a la aten-

ción médica de emergencia necesaria, HB5239, que amplía las leyes de protección de Illinois, y HB4867, que aclara y amplía la Ley de Derechos Humanos de Illinois para prohibir la discriminación basada en decisiones de salud reproductiva.

“Ya no es suficiente legislar para el momento actual. Lamentablemente, tenemos

que anticipar un futuro en el que la Corte Suprema y otros malos actores restrinjan y castiguen aún más a las mujeres que buscan ejercer sus derechos médicos y el control sobre sus cuerpos. Estas nuevas leyes garantizarán que las mujeres en Illinois y las que viajan desde fuera del estado puedan evitar la persecución y la discriminación en todos los niveles", dijo el gobernador JB Pritzker. HB5239 amplía aún más estas protecciones. Según la ley, las jurisdicciones estatales y locales no pueden proporcionar ninguna información ni gastar ningún recurso para ayudar a una entidad de fuera del estado a investigar la atención médica legal, incluidos los abortos o la atención de afirmación de género, brindada en Illinois.

"Hemos tomado medidas firmes para salvaguardar la atención médica vital con estas dos piezas clave de legislación", dijo la senadora estatal Celina Villanueva (D - Chicago). "En conjunto, estos proyectos de ley reflejan nuestra dedicación a la protección de los servicios de salud esenciales y al respeto de los derechos individuales". HB4867 agrega decisiones de salud reproductiva a la Ley de Derechos Humanos de Illinois. Las decisiones de salud reproductiva incluyen un amplio espectro

de decisiones personales con respecto al aborto y el control de la natalidad, la atención de fertilidad o esterilización, la atención de manejo de abortos espontáneos, las tecnologías de reproducción asistida como la fertilización in vitro y la atención prenatal, intranatal y posnatal.

HB 4867 aclara y extiende las protecciones existentes contra la discriminación al garantizar que los habitantes de Illinois tengan derecho a participar en

la toma de decisiones de salud reproductiva sin enfrentar la discriminación. También complementa las protecciones existentes que se encuentran en la Ley de Salud Reproductiva, que protege a los habitantes de Illinois de la interferencia del Estado de Illinois con los derechos fundamentales de las personas a tomar decisiones autónomas sobre su salud reproductiva. Según esta enmienda, sería una violación de los derechos civiles que:

Un empleador despida a un empleado por intentar formar o ampliar su familia con la ayuda de la fertilización in vitro

Un proveedor de vivienda se niegue a un posible inquilino a alquilar un apar-

tamento porque la persona se ha practicado un aborto. Un banco o cooperativa de crédito se niegue a un solicitante un préstamo o crédito porque se utilizaría para tratamientos de fertilidad

"Los derechos reproductivos están bajo ataque en estados de todo el país, pero aquí en Illinois, tenemos líderes que se alzan con valentía para contraatacar", dijo la directora ejecutiva de Personal PAC, Sarah Garza Resnick. "Gracias al gobernador Pritzker y a nuestros campeones legislativos, Illinois sigue siendo un baluarte en el Medio Oeste contra los esfuerzos por despojarnos de nuestros derechos a controlar nuestros cuerpos.

## Berwyn Family Says CDPH's Lead Program Provides Peace of Mind



With the help of HUD grant funding totaling \$700,000, Cook County Department of Public Health provided lead abatement services to 48 suburban Cook

County households in 2023. "Thanks to HUD's investment, 127 children in suburban Cook County are now lead-safe," said Dr. LaMar Hasbrouck, CCDPH's chief operating

officer. After Berwyn residents Lisa Aguilar and James Pesch's son, now 4, was diagnosed with lead poisoning last June, the couple applied for the Cook County Department of Public Health's Lead Hazard Reduction Program and was approved for an \$18,000 HUD grant in August. In January, the health department assigned a nurse to the family's son, replaced the front and back doors and screens and all 13 windows in the family's home, painted the walls and ceilings in one of their rooms and replaced the exterior door of their garage. # Gov. Pritzker Signs Landmark Legislation Further Expanding Reproductive Rights in Illinois

On Wednesday, Governor JB Pritzker, joined by legislators and civil rights leaders, signed multiple bills designed to further protect reproductive rights in Illinois. The bills signed includes HB581, which ensures that pregnant women can access needed emergency medical care, HB5239, which expands Illinois' shield laws, and HB4867, which clarifies and expands the Illinois Human Rights Act to prohibit discrimination based on reproductive health decisions.

"It is no longer enough to legislate for the current moment. We sadly have to anticipate a future when the Supreme Court and other bad actors further restrict and punish women seeking to exercise their medical rights and control over their bodies. These new laws will ensure that women in Illinois and those travelling from out of state can avoid persecution and discrimination on every level," said Governor JB Pritzker. HB5239 further expands these protections. Under the law, state and local jurisdictions cannot

and Pesch said they have "peace of mind" now that their son's blood lead levels are within normal range. "We are very happy. We don't have the problem of worrying about our son's health anymore," said Pesch. With 93 percent of its housing stock built before 1978, Berwyn has the second highest number of child referrals for elevated blood lead levels in CCDPH's jurisdictions, Hasbrouck said. provide any information or expend any resources to help an out of state entity investigate legal healthcare, including abortions or gender affirming care, provided in Illinois.

"We've taken strong steps to safeguard vital medical care with these two key pieces of legislation," said State Senator Celina Villanueva (D - Chicago). "Together, these bills reflect our dedication to protecting essential health services and respecting individual rights." HB4867 adds reproductive health decisions to the Illinois Human Rights Act. Reproductive health decisions include a broad continuum of personal decisions regarding abortion and birth control, fertility or sterilization care, miscarriage management care, assisted reproductive technologies such as in vitro fertilization, and prenatal, intranatal, and postnatal care.

HB 4867 clarifies and extends existing anti-discrimination protections by ensuring Illinoisans have the right to engage in reproductive health decision-making without facing discrimination.

It also complements existing protections found in the Reproductive Health Act, which protects Illinoisans from State of Illinois interference with the fundamental rights of individuals to make autonomous decisions about their reproductive health. Under this amendment, it would be a civil rights violation for:

- An employer to terminate an employee for seeking to start or expand their family with the assistance of in vitro fertilization
  - A housing provider to refuse a prospective tenant an apartment rental because the person had an abortion
  - A bank or credit union to deny an applicant a loan or credit because it would be used for fertility treatments
- "Reproductive rights are under attack in states across



this country, but here in Illinois, we have leaders who stand up boldly to fight back," said Personal PAC CEO Sarah Garza Resnick. "Thanks to Gov.

Pritzker and our legislative champions, Illinois remains a bulwark in the Midwest against efforts to strip away our rights to control our bodies."

You may have noticed your streets and alleys a little bit cleaner this summer, and that's thanks to a program that President Larry Dominick and the Town of Cicero support to keep the teenagers in

town busy working. "We are cutting and trimming. My job is to make sure that all the weeds are gone and there is no garbage left between the totes," said Manuel Davila the lead coordinator of the summer

program at Public Works. "I have to make sure the alleys are nice and clean." Different crews are going around all throughout town cleaning up with weed whackers, picking up garbage and just making

and keeping our town beautiful. "This is a great program because by us moving all the garbage cans there's no garbage left for the rodents," shared Davila. He oversees 12 teenagers in his bus and describes them as, "awesome kids." Some have weed whackers, others carry blowers and the rest come and pick up the garbage. "If it's something very large I contact my supervisor and he will send a dumb truck or a sweeper," said Davila. "It's a very good program because you keep them away from trouble and at the same time they make a couple of dollars." Davila is a Cicero resident of more than 47 years and stated, "I love my Town!"

## Assessor Kaegi Calls on Lawmakers to Work Together on "Circuit Breaker" for Property Tax Relief

Cook County Assessor Fritz Kaegi urged lawmakers across the county and state to collaborate on a "circuit breaker" policy to provide relief for homeowners facing large increases in their tax bills. Under a "circuit breaker" program, homeowners whose property taxes increase beyond their ability to pay would receive assistance with their bills. These programs typically benefit seniors on fixed incomes, low-income homeowners in gentrifying neighborhoods, and individuals who experience a loss of primary income. Most states across the country offer some form of circuit breaker program. A circuit breaker proposal could be instituted by both the Cook County Board of Commissioners and the Illinois General Assembly. The structure for such a program already exists at the state level, but currently lacks funding. Across the south and west suburbs, tax bills grew dramatically for homeowners. According to an analysis from the Cook County Treasurer's Office,



the median residential bill was \$6,117, an increase of nearly 20 percent. Assessor Kaegi also detailed

several other possibilities for property tax relief during Monday's hearing, including changes to the

longtime homeowners' exemption to expand eligibility and the use of Tax Increment Financing funds.

## HUD Invests \$1.5 Million to Modernize Homes for Illinois Families

On Wednesday, July 31, the U.S. Department of Housing and Urban Development (HUD) announced the recent completion of two transactions totaling \$1.5 million to finance energy efficient and climate resilient improvements for affordable homes in Illinois under the Green and Resilient Retrofit Program (GRRP). The rehabilitations will update existing common spaces, including replacing roofing, windows, doors, and lighting for very low-income seniors. Renovations will also include upgrades to mechanical, plumbing, and electrical systems, electrification, insulation, renewable energy




integration, and stormwater management. The first project is a \$750,000 loan to Brainerd Senior Center, a 60-unit, six-story building in Chicago, Illinois. The second is a \$750,000 grant to Round Barn Manor, a 156-unit, two-story building in Champaign, Illinois. These transactions are the

first to use GRRP funds for construction projects in Illinois. Constructed in 2000, Brainerd Senior Center will update all 60 units as well as existing common spaces, which includes replacing roofing, windows, insulation, doors, lighting, electrification improvements, and more. HUD provides rental

assistance under the Section 811 Project Rental Assistance program to 12 of the households at the property. The project is also participating in the City of Chicago Decarbonization program, which enables HVAC system updates and the replacement of appliances with electric and energy-efficient alternatives.

HUD brinda asistencia para el alquiler en virtud del programa de Asistencia para el Alquiler del Proyecto Sección 811 a 12 de los hogares de la propiedad.
