# **Advocates of Humboldt Park's Encampment Call on City for Support**

Supporters of the Humboldt Park tent rallied encampment together on Wednesday for a press conference urging the City of Chicago to halt the upcoming plans to clear the area. The encampment is located in Humboldt Park and the city plans to remove it starting Friday morning. "Closing off public space and forcing people to move to another location is not a solution to homelessness. While some people living in Humboldt Park have been connected to housing options, many have not. said Ali Simmons, Senior Case and Outreach Worker with Chicago Coalition to



end Homelessness. After clearing it out, Chicago police and the Park District would enforce municipal codes that prohibit overnight stays and tents in park. Alderperson Jessie Fuentes (24<sup>th</sup> ward) said those "who are displace would be offered access to support services as well as the option to move into housing or shelters with fewer rules of entry.

Spangler, con Heartland Alliance Health. "Algunas personas desplazadas tienen alojamiento, pero los trabajadores sociales necesitan comunicarse con ellas durante un período de meses antes de trasladarlas a una vivienda. Otras personas que no han sido conectadas con una vivienda tienen una

but that has not come through vet and it is not going to come through by December 6," said Daisy Vasquez, a resident of Humboldt Park, "I don't want to leave the Humboldt Park area. This is the only neighborhood I really know, and my hospital and doctors are in this area." Humboldt Park is a site that is well known among the unhoused and service providers who work with them. "Displacing people disconnects outreach workers at Heartland Alliance Health and other agencies from working to house them. When people are in the park, outreach workers know where to find them," said Ryan Spangler with Heartland Alliance Health. "Some people being displaced have housing placements, but outreach workers need to connect with them over a period of months before actually moving them into housing. Others who have not been connected to housing are in even more need of these crucial services." The city will move to a "One System Initiative" for addressing the problem of homelessness starting Jan. 1, 2025.

Ramos holds a Ph.D. in Anthropology with a minor in Latina/ Latino Studies from the University of Illinois, Urbana-Champaign, where she also completed her Bachelor's Degree. "I'm eager to get started working with an incredible team of state employees, parents and families, advocates, and early childhood to providers create something exceptional that will give every infant, toddler, and young child an opportunity for a strong and healthy start." said Dr. Teresa Ramos. In collaboration with CityKey business partners and prominent Chicagoans, the video demonstrates the new online platform and highlights how Chicagoans can use their ID. It features Sweet Mandy B's, Momentum Coffee, Museum of Illusions Chicago, My Block, My Hood, My City Founder and more. Residents can submit their CityKey application by visiting www.getcitykey.com, and once their information is verified, they'll receive their CityKey through the mail. Applicants will

need to upload the proper Proof of Identity and Proof of Residency documents along with a clear passportsize photo to be approved. The information submitted is retained according to the City's retention schedule and is only kept after the applicant acknowledges and completes the online application process. CityKey is a free and optional governmentissued 4-in-1 ID serving as a Ventra card, library and Chicago Rx Prescription

# With Cold Temps Settling in, IDPH Reminds Illinoisans to Get Protection from Seasonal Respiratory Bugs

Now that colder temperatures have arrived, the Illinois **Department of Public** Health (IDPH) is reminding Illinoisans to prepare for the coming respiratory virus season by getting the recommended shots for flu and COVID-19 and **RSV. While the IDPH** Seasonal Respiratory **Illness Dashboard shows** the overall illness level in Illinois remains Low, public health officials expect viral activity to increase as the holiday season and time for indoor gatherings kicks into gear. IDPH officials

are also warning of a significant increase in whooping cough (pertussis) cases this year. The largest monthly total in 20 years was recorded in **October when 408 cases** were reported, more than double the number in October 2023. The FDA and CDC have approved new vaccines for COVID-19 and flu as well as updated who can receive the **RSV** vaccines. City Colleges of Chicago will open Chicago's first Education Workforce

Center (EWC) at Harry S Truman College. The EWC will serve as the

epicenter for education professionals and offer curated resources, practical

guidance, technology, employment supports, and examples of innovation to inform the advancement of educators in Chicago and around the state of Illinois. "Supporting educators is important because it directly impacts student success by ensuring teachers feel valued, have the resources they need to teach, and are able to maintain their well-being which in turn leads to better student outcomes and retaining that teacher," said Dr. Shawn Jackson, president of Harry S Truman College. "When teachers are supported,

we all win." The early child care sector has lost thousands of workers since the pandemic with many day care centers closing. In addition, many organizations that provide early care and education services share that it is difficult to find qualified staff to fill the many vacancies. At the same time, many current educators are leaving the profession due to 'burn out' with some citing low wages as the reason for leaving the profession altogether (source: Nationals Women's Law Center). The Education Workforce Center will start with tools for education professionals in early childhood (birth to pre-school) and grow to support grammar school educators, then high school educators, and so on. The EWC will be free and open to educators through an application process.

# Free Doula Program Launches in Cook County

Cook County officials Health on Tuesday launched a new program that will address the county's high maternal mortality crisis. Officials announced the start of free doula care for pregnant women, a program designed to help families and hopefully reduce health disparities. "Doulas empower families by providing information about childbirth options and advocating for patients' needs, helping to ensure women and children have informed options during labor and delivery," said Cook County Board President Toni Preckwinkle.

An Illinois Department of Public Health task force found that African American women in Illinois are about three times as likely

to experience a pregnancyrelated death as white and Hispanic women. During the press conference, health care professionals and doulas expressed that families that have doulas have less stress, fewer complications, and a more positive postpartum experience. "Our role is to help women find their voices and use their voices. We do not speak for them. Instead, we support them in their self-advocacy," said Cook County Health Reproductive Life Planning Coach and Doula Shalonda Carter.

"I'm thrilled that the Board has approved a contract that will allow Cook County Health to provide free doula services to our patients in need. In Cook County and across the country, we face a maternal mortality crisis, but it's a preventable one. We need to be doing everything we

can to support the health of mothers before, during and after pregnancy, and doula services are a critical part of that. As Commissioner, I've championed and secured \$1 million in funding for accessible doula services, and I'm grateful that our County Health System is taking this issue on. I look forward to seeing how this new program can help reduce disparities in care and protect the health and safety of mothers and children," said Cook County Commissioner Donna Miller. Cook County Health will add 10 doulas and begin offering services to patients in January.
