The City of Chicago is providing an opportunity for recently incarcerated individuals returning home. As financial instability can be a leading barrier to an effective reentry after incarceration, the Chicago Treasurer's Office (CTO) recently announced the launch of The Second Act: Second Chances program, with the help of the Mayor's Office. The program will specialize in financial education workshop at the 2025 Money Matters Institute (MMI).

"Reentry is about more than just finding a job—it's about long-term financial security," said Chicago City Treasurer Melissa Conyears-Ervin. "This initiative equips returning citizens with the tools they need to build a new life, break free

from cycles of poverty re-incarceration, and contribute to the financial well-being of their communities." This initiative offers the critical financial tools needed to help returning citizens rebuild their lives. In April of 2024, City Treasurer Conyears-Ervin collaborated with Chase Bank, the Chicago Urban League, and TransUnion to create MMI to offer Chicagoans of all ages and incomes with money management skills and knowledge.

This month, in partnership with the Mayor's Office of Reentry, local banks, and nonprofit organizations, *The Second Act: Second Chances* will begin to provide returning citizens

with customized financial education tailored to their needs. Key topics will include

•Budgeting & Financial Planning: Developing strategies for managing limited resources effectively.

•Credit Repair & Banking Access: Rebuilding financial credibility and establishing banking relationships.

•Debt Reduction & Employment Support: Connecting participants with job readiness and debt reduction resources.


According to City Treasurer Conyears-Ervin, participants will have access to one-on-one financial counseling with HUD-certified advisors. Joseph Mapp, Director

of the Office of Reentry, added, "The Office of Reentry is proud to partner with Chicago's Treasurer's Office to offer an invaluable service. For many, crime is not about inherent malicious intent-it starts as a means of survival, a way to secure money when no other options seem available. Unfortunately, leaving prison often means returning to the same financial hardships that led to incarceration in the first place. That's why employment alone is not enough. Financial literacy is critical to breaking cycles of poverty and recidivism." In addition, CTO shared that 60 percent of returning citizens remain unemployed a year after release, and 75 percent

face substantial financial debt, including court fees experience homelessness due to financial instability. For

face substantial financial debt, including court fees and loans, which hinder their path to stability. Additionally, formerly incarcerated individuals are ten times more likely to

### **Current State Flag is Decisive Winner in Flag Redesign Contest**

overwhelmingly favors retaining the current state flag, Illinois Secretary of State Alexi Giannoulias announced following the five-week voting period to consider a redesign of the flag. Voters had the option to choose their favorite design from one of the Illinois Flag Commission's Top 10 new designs, or one of three former flag designs, including the current one, which has not had a major redesign in the past century. Of the nearly 385,000 votes that were received, over 165,000, or 43 percent, were cast for the current Illinois State flag, which received more votes than the next five top designs combined. The Illinois Flag Commission will prepare a report detailing its findings and recommendations to the General Assembly by April 1. Lawmakers will then vote on whether to adopt a new flag, return to a previous iteration or keep the current one. Senate Bill 1818, sponsored by State Senator Doris Turner (48th District—Springfield) and State Representative Kam Buckner (26th District— Chicago), was signed into law by Governor JB

Pritzker in 2023, creating



the commission to gauge public desire for a new flag. The commission selected its Top 10 finalists in December from the 4,844 entries it received during the six-week submission period that closed in October.

Εl pueblo pide abrumadoramente retener la actual bandera del estado. anunció el Secretario de Estado de Illinois, Alexi Giannoulias tras el período de votación de cinco semanas de considerar un rediseño de la bandera. La Comisión de la Bandera de Illinois preparará un reporte detallando sus hallazgos v recomendaciones a la Asamblea General para el 1º de abril. Waukegan and Woodstock. These DMVs offer nonappointment, walk-in services on Saturdays.

•Six DMV appointmentonly locations have expanded Saturday hours to 7:30 a.m. to 5 p.m.: Chicago North (5401 N. Elston Ave.), Deerfield, Lombard, Naperville, Schaumburg and Springfield (Wabash Avenue). Appointments at these facilities must be made in advance.

•Nine appointment-only facilities are operating from 7:30 a.m. to Noon on Saturdays: Bloomington, Champaign, Chicago South (9901 S. Martin Luther King Dr.), Granite City, Marion, Midlothian, Peoria, Rockford (Central) and Silvis. Appointments at these facilities must be made in advance.

#### Illinois Overdose Deaths on Decline

The Administration of Governor JB Pritzker announced that Illinois recorded an 8.3 percent drop in overall drug overdose deaths in 2023, exceeding a nationwide decline of 4 percent. Specifically, opioid overdose deaths declined 9.7 percent in the state, compared to 3 percent nationally. The new data shows 3,502 overdose deaths in Illinois from all causes in 2023, 317 fewer than in 2022. The new data comes as the Illinois Department of Public Health (IDPH) unveiled an expanded Overdose Data Dashboard that shares more data and makes the tool easier to use for both researchers and the general public. Looking just at opioids, there were 2,855 fatalities attributed to opioid overdoses in Illinois in 2023, 305 fewer than 2022, a decrease of 9.7 percent. In 2022, total overdose deaths in Illinois increased 5.1 percent from 2021, and deaths involving opioids were up 8.2 percent. IDHS has distributed 1 million 2-dose boxes of Narcan (generically called naloxone) to communityorganizations,



substance use disorder treatment centers, harm reduction organizations, hospitals, and clinics across Illinois in the last four years. If you or someone you know has an opioid use disorder, there is help, including treatment, available immediately, 24 hours a day, seven days a week. With the Medication Assisted Recovery Now (MAR NOW) service, a care manager can help callers determine the best treatment options and connect them to a provider for an immediate telephone appointment and medication prescription. ## Disminuyen las Muertes por Sobredosis en Illinois

La Administración del Gobernador JB Pritzker anunció que Illinois registró un 8.3 por ciento de disminución en las muertes por sobredosis de drogas en general en el 2023, excediendo una disminución a nivel nacional del 4 por ciento. Específicamente, muertes por sobredosis de opioides bajaron un 9.7 por ciento en el estado, comparado con un 3 por ciento a nivel nacional. El nuevo dato llega del Departamento de Salud Pública de Illinois (IDPH) revelado y ampliado por Ovedose Data Dashboard que comparte más datos y

facilita el uso para ambos investigadores y el público en general. Mirando solo los opioides, hubo 2,855 muertes atribuídas a sobre dosis de opioides en Illinois en el 2023, 305 menos que en el 2022, una disminución del 9.7 por ciento. En el 2022, la sobre dosis total de muertes en Illinois aumentó 5.1 por ciento del 2021 y las muertes involucrando opioides subieron un 8.2 por ciento. ## Suburban Chicago Businessman Indicted on Immigration Fraud Charges

Chicago businessman has been indicted on federal fraud charges for allegedly providing false and fraudulent information to U.S. authorities to obtain immigration benefits for his foreign national clients. JOSE GREGORIO SOSA CARDONA operated Delta Global Solutions, Inc., which assisted individuals in applying for asylum, immigrant visas, lawful permanent residence cards, and other immigration benefits. From 2020 to 2024, Sosa Cardona conspired with two employees of his firm and others to knowingly provide false and fraudulent information to the U.S. Citizenship and Immigration Services on behalf of his foreign national clients who were seeking benefits, according to an indictment unsealed today in U.S. District Court in Chicago. The indictment accuses Sosa Cardona of, among other things, fabricating foreign law enforcement reports and foreign political party membership letters to falsely corroborate his clients' asylum claims. Sosa Cardona also falsely represented to U.S. immigration officials that he was an attorney licensed to practice law in Ohio, when, in fact, he was not an attorney and not authorized to represent applicants in immigration proceedings before the USCIS, the indictment states.

Sosa Cardona, 40, of Downers Grove, Ill., is charged with one count of conspiracy to defraud the United States and commit immigration fraud, four counts of falsifying applications for immigration benefits, and two counts of making a false statement to the USCIS. Sosa Cardona was arrested this morning. He was arraigned this afternoon in federal court in Chicago and pleaded



not guilty to the charges. A detention hearing is scheduled for March 12, 2025, at 1:00 p.m. The indictment was announced by Morris Pasqual, Acting United States Attorney for the Northern District of Illinois, Matthew Scarpino, Special Agent-in-Charge of U.S. Immigration and Customs Enforcement's Homeland Security Investigations in Chicago, Ramsey E. Covington, Acting Special Agent-inCharge of IRS Criminal Investigation Chicago Field Office, and Ruth Mendonça, Inspector-in-Charge of the Chicago Division of the U.S. Postal Inspection Service. Valuable assistance was provided by the USCIS Fraud Detection and National Security Directorate. The government is represented by Assistant U.S. Attorney Jeffrey Snell.

The public is reminded that an

indictment contains only charges and is not evidence of guilt. The defendant is presumed innocent and entitled to a fair trial at which the government has the burden of proving guilt beyond a reasonable doubt. Each count of falsifying immigration applications is punishable by up to ten years in federal prison, while the conspiracy and false statement counts each carry a maximum sentence of five years.





## Pritzker Propone Política de Prohibición de Teléfonos Celulares para las Aulas de Illinois

Gobernador JB Pritzker se unió a la Tnt.Gobernadora Juliana Stratton, maestros, administradores escolares y funcionarios municipales para proponer la prohibición de los teléfonos celulares en el salón de clases en las escuelas de Illinois. # Pritzker Proposes Cell Phone Ban **Policy for Illinois Classrooms**



Last Thursday, Governor JB Pritzker joined Lt. Governor Juliana Stratton, teachers, school administrators, and municipal officials to propose a classroom cell phone ban in schools across Illinois. A key initiative mentioned in the Governor's State of

the State Address, the legislation would require all public-school districts in Illinois to adopt a wireless communication device policy that limits the use of personal devices during class instruction time. According to a Pew research study, 72 percent of high school

teachers identified cell phone distraction as a "major problem" in their classroom. Similar policies have already been adopted by eight other states, and the initiative has proved to be widely popular, with 68 percent of adults in favor of in-class electronics bans. In Illinois, several school

districts—in Champaign, Springfield, and Peoria have already implemented policies limiting cell phone use. This proposed bill would require districts to implement a ban on personal phone use during instructional periods, with the following exceptions: •In the event of an emergency or in response to an imminent threat.

- •When a teacher or instructor has authorized the student to use a wireless communication device for educational purposes e.g. Chromebook use, technology-based activities, etc.
- •When licensed a physician determines that the possession or use of a wireless communication device is necessary for the health or well-being of the student.
- •To fulfill an Individualized Education Plan or 504 plan.
